



RELEASE AND TERMINATION OF LEASE SURFACE TRANSPORTATION BOARD

By this Release and Termination of Lease (the "Release"), the David J. Joseph Company ("Joseph"), as lessor, and ISG Railways, Inc. ("ISG"), as lessee, do agree as follows.

1. A Memorandum of Railroad Equipment Lease Agreement dated as of August 27, 1998 (the "Lease") between DJJ Transportation Services, Inc. ("DJJ"), as lessor, and Steelton & Highspire Railroad Company ("S&H"), as lessee, was recorded at the Surface Transportation Board (the "Board") on October 7, 1998 under Recordation No. 21701 for 25 railcars numbered SH 6150-6174, inclusive (the "Equipment").

2. A Memorandum of Assignment and Assumption Agreement of the lease dated as of December 17, 1998 between DJJ, as assignor, and Star Bank, N.A. ("Star"), as assignee, was recorded at the Board on January 8, 1999 under Recordation No. 21701-A for the Equipment.

3. A Memorandum of Options, Rights of First Refusal and Remarketing Rights dated as of December 17, 1998 (the "Options and Rights") between DJJ, as seller, and Star, as buyer, was recorded at the Board on January 8, 1999 under Recordation No. 21701-B for the Equipment.

4. A Memorandum of Assumption of Lease Agreement dated as of May 15, 2003 between U.S. Bancorp Equipment Finance, Inc. ("US Bancorp"), successor-in-interest to Star, as lessor, and ISG Railways Inc. ("ISG"), as assumptor, was recorded at the Board on July 29, 2003 under Recordation No. 21701-C for the Equipment.

5. A Memorandum of Assignment of Lease dated as of December 15, 2005 between US Bancorp, as assignor, and The David J. Joseph Company (f/k/a DJJ), as assignee, was recorded at the Board on December 29, 2005 under Recordation No. 21701-D for the Equipment.

6. The Lease and the Options and Rights are referred to as the "Lien Documents."

NOW, THEREFORE, in consideration of the premises contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Joseph and ISG do hereby acknowledge and confirm for the public record:

a. That all sums due with respect to the Equipment under the Lien Documents have been fully discharged and satisfied.

b. The satisfaction and release of their interests under the Lien Documents.

2. This Release may be executed in any number of counterparts, each executed counterpart constituting an original but all together only one Release.




