

**SURFACE TRANSPORTATION BOARD AMENDMENT OF LIEN AND SECURITY INTEREST**

This Amendment of Lien and Security Interest (this "Amendment") is given this 30<sup>th</sup> day of October, 2006 by LINDELL BANK & TRUST COMPANY ("Bank").

WHEREAS, Bank has filed certain documents with the Surface Transportation Board ("the STB"), including, but not limited to, the following documents:

3. Documents dated August 17, 1992, bearing STB Recordation No. 17924-A and recorded August 25, 1992;
4. Security Agreement dated August 17, 1992, bearing STB Recordation No. 17924-B and recorded August 25, 1992;
5. Purchase Agreement dated April 20, 1993, bearing STB Recordation No. 17924-C and recorded May 24, 1993;
6. Partial Release dated April 20, 1993, bearing STB Recordation No. 17924-D and recorded May 28, 1993;
7. Partial Release dated December 23, 1994, bearing STB Recordation No. 17924-E and recorded May 26, 1995;
8. Amendment dated August 11, 1995, bearing STB Recordation No. 17924-F and recorded August 29, 1995;
9. Amendment dated December 27, 1995, bearing STB Recordation No. 17924-G and recorded January 19, 1996;

13. Amendment dated May 8, 2006 bearing STB Recordation No. 17924-1 and recorded May 10, 2006.


WHEREAS, pursuant to those documents previously filed with STB, Southern Illinois Railcar Company ("SIRC") granted Bank a security interest or lien in certain railcars and related collateral (the "Released Collateral");

NOW THEREFORE, in consideration of the premises contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Bank hereby submits the following:

1. Bank hereby releases any and all liens, claims, security interests and other encumbrances in all Released Collateral set forth and described in any prior STB filings filed or made by the Bank, including, but not limited to, those filings set forth above (the "Prior STB Filings"); provided, Bank shall continue to have a first priority security interest in all of SIRC's right, title and interest in and to the railcar collateral, including the proceeds thereof, set forth on Exhibit A attached hereto.
2. This Amendment shall supersede and release any and all Prior STB Filings and shall be recorded with the Surface Transportation Board.


