

MEMORANDUM OF MORTGAGE**

THIS Supplement is made and entered into as of June ^{28th}, 2007, between MIDWEST ETHANOL TRANSPORT, LLC, a Minnesota limited liability company (the "Debtor"), and HOME FEDERAL SAVINGS BANK, a federally chartered stock savings bank organized under the laws of the United States (the "Secured Party"). 


