PARTIAL TERMINATION OF LEASE AGREEMENT

THIS PARTIAL TERMINATION OF LEASE AGREEMENT is made and entered into as of September 20, 2007 by and between The Kansas City Southern Railway Company (successor to Carland, Inc.), as lessor (the "*Lessor*") and The Kansas City Southern Railway Company (successor to Louisiana and Arkansas Railway Company), as lessee (the "*Lessee*").






