
THIS CONTRACT, dated as of the 15th day of October, 1974, by and between Security National Bank, a national banking association organized and existing under the laws of the United States, as Trustee (hereinafter called "Seller") pursuant to Richmond Leasing Company Equipment Trusts, Series 4, dated as of September 1, 1972 and Series 5 dated as of April 1, 1973, and Richmond Leasing Company, a corporation organized and existing under the laws of the State of Delaware (hereinafter called "Buyer").

In consideration of \$10 in hand paid, receipt of which is hereby acknowledged, Seller does hereby sell and convey to the Buyer the railroad cars (the "Railroad Cars") described in Exhibit A attached hereto and made a part hereof for all purposes.

Seller hereby represents that it has not, prior to the date hereof, conveyed title to the Railroad Cars to any other party, nor has Seller created, incurred or, to its knowledge, suffered to exist any liens or encumbrances (including any leasehold interest) against the Railroad Cars, other than the Existing Leases described in the attached Exhibit B.
