WITNESSETH:

WHEREAS, by Security Agreement-Trust Deed dated as of March 1, 1991 by and between U.S. Bank National Association (as successor Owner-Trustee under that certain Trust Agreement dated as of March 1, 1991 between The Connecticut National Bank and Chase Manhattan Service Corporation) and Wilmington Trust Company (as "Security Trustee") duly filed and recorded with the Surface Transportation Board bearing recordation number 17254-A and all supplements and amendments thereto (the "Security Agreement"), the Owner-Trustee pledged certain equipment defined and described in the Security Agreement to the Security Trustee; and
