**RELEASE OF LIEN

SURFACE TRANSPORTATION BOARD

This Release of Lien of Railroad Equipment Lease (the "Release") releases the lien created by that certain Railroad Equipment Lease dated as of September 24, 1979 (the "Lease"), bearing Recordation No. 11210, between The David J. Joseph Company as Lessor ("Lessor") (as assigned and recorded under Recordation No. 16981) and Western Railroad Company, as Lessee ("Lessee"), with respect to the fifty (50) railcars bearing reporting marks within the series WRRC 424-473, inclusive (hereinafter, the "Equipment").

WHEREAS, the Equipment has been returned and such Lease was terminated.

NOW, THEREFORE, in consideration of the premises contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lessor submits the following:

1. Lessee and Lessor have agreed to terminate the Lease between the parties effective as of December 31, 1991.

2. The Lease holding Recordation No. 11210 and subsequent filings are hereby terminated. The David J. Joseph Company ("Lessor") hereby releases any and all liens created by or arising by the recordation of these filings.

3. This Release shall be recorded with the Surface Transportation Board so as to record the release of the lien against the Equipment constituted by the Lease.


