**FULL RELEASE OF LIEN

RAILROAD EQUIPMENT LEASE**

This Release of Lien of Railroad Equipment Lease (the "Release") releases the lien created by that certain Railroad Equipment Lease dated as of May 15, 1998, Amendment No. 2 dated as of March 26, 2002 and Amendment No. 3 dated as of November 10, 2004 bearing Recordation Nos. 21507, 21507-A and 21507-B, respectively (collectively, the "Lease"), between The David J. Joseph Company as Lessor ("Lessor") and Martin Marietta Materials, Inc.
