

SURFACE TRANSPORTATION BOARD

This Release (the "Release") is entered into as of March 18, 2008 between The David J. Joseph Company, a Delaware corporation ("Joseph") and Greyhound Financial Corporation, a Delaware corporation ("Greyhound").

WHEREAS, Joseph and Greyhound are parties to a Purchase and Sale Agreement dated as of July 16, 1990 (the "Agreement") pursuant to which (a) Joseph purchased the railcars bearing reporting marks WRRC 200-254, not inclusive (the "Railcars"); and

WHEREAS, such Railcars were subject to a Lease (the "Lease");

WHEREAS, Joseph and Greyhound memorialized the Agreement of record by filing a Assignment and Assumption Agreement dated as of July 16, 1990 between Joseph and Greyhound (the "Assignment and Assumption") with the Surface Transportation Board (the "STB"); and


WHEREAS, the Assignment and Assumption was recorded with the STB on August 28, 1990 and assigned recordation number 16982,


