

**PARTIAL RELEASE OF SECURITY INTEREST UNDER FIRST MORTGAGE**

THIS PARTIAL RELEASE OF SECURITY INTEREST dated June 20, 2008 is made and entered into by the undersigned, WELLS FARGO BANK NORTHWEST, NATIONAL ASSOCIATION, successor-in-interest to First Security Bank, National Association (the "Security Trustee").

For good and valuable consideration, the receipt and sufficiency of which are acknowledged, the Security Trustee hereby terminates, releases and discharges its security interest in the railroad equipment set forth on Schedule 1 attached hereto which has been deemed to have suffered an Event of Loss.


