

THIS TERMINATION OF LEASE is made as of August 1, 2008 by **BC Rail Ltd.** (the "Lessor").


WITNESSETH:

1. Lessor as lessor and **Mosinee Paper Company** as lessee entered into a Lease of Railroad Equipment dated as of March 8, 1990 covering six (6) 52'8" 70-ton bulkhead flatcars marked **BCOL 16722, BCOL 16739, BCOL 16801, BCOL 17129, BCOL 17216 and BCOL 17265**; and
