BILL OF SALE

SURFACE TRANSPORTATION BOARD

KNOW ALL MEN BY THESE PRESENT that the undersigned Estate of Ruth S. Hiler (hereinafter referred to as the "Seller"), in consideration of the sum of eight thousand (\$8,000.00) dollars paid by Mark T. Hiler (hereinafter referred to as the "Purchaser"), the receipt of which is hereby acknowledged (the same being paid in full and in cash), does hereby bargain and sell to the said Mark T. Hiler effective January 1, 2002 the following property:

One covered hopper car, 100 ton, 4750 cubic feet capacity; current marks, NOKL67042; year built, 1980; management agent, Charter Meridian Services Association; including current lease agreements, management agreements, insurance policies, accounts payable, accounts receivable, and painting reserve.

And the Seller does hereby represent to the Purchaser that, concerning the aforesaid covered hopper car, it has no creditors and owes no money to any person, firm or corporation, that it has paid in full for all the property hereby conveyed by this agreement, and that there are no liens or encumbrances of any kind on any such property, and warrant that it can convey a free and clear title to all thereof, SUBJECT ONLY to the current lease and management agreements with Charter Meridian Services Association and any regulations, conditions, or limitations contained therein.
