AMENDMENT TO MEMORANDUM OF EQUIPMENT SECURITY AGREEMENT
(Surface Transportation Board)

THIS AMENDMENT TO MEMORANDUM OF EQUIPMENT SECURITY AGREEMENT dated this 13th day of March, 2009, between U.S. BANK NATIONAL ASSOCIATION, a national banking association ("Owner Trustee"), as successor in interest to Fleet National Bank, not in its individual capacity, except as expressly provided herein, but solely as Owner Trustee under Trust Agreement dated as of November 1, 1996 between Owner Trustee and Connell Finance Company, Inc., as Mortgagor, U.S. BANK NATIONAL ASSOCIATION, as successor in interest to Fleet National Bank (the "Paying Agent") and CCG TRUST CORPORATION, having an office at #1 Chelston Park, Collymore Rock, St. Michael, Barbados, West Indies, as Mortgagee (together with its successors and permitted assigns, the "Lender").

WHEREAS, as security for its obligations under that certain Equipment Security Agreement dated as of November 1, 1996, among the Owner Trustee, the Paying Agent and the Lender (the "Equipment Security Agreement"), Owner Trustee assigned and granted to the Lender all of its right, title and interest in one hundred ninety (190) covered hopper railcars, manufactured by ACF Industries, Inc., and as more fully described in Schedule I thereto (the "Units"); and

WHEREAS, the Memorandum of Equipment Security Agreement (the "Memorandum of Equipment Security Agreement") evidencing such Equipment Security Agreement was filed at the Surface Transportation Board pursuant to Section 11301(a) of Title 49 of the *United States Code* on November 7, 1996 at 3:00 p.m. under Recordation Number 20357; and

WHEREAS, the units have been remarked and renumbered pursuant to the terms of the Replacement Lease.

NOW THEREFORE, the Owner Trustee and Lender, for good and valuable consideration, agree that:

Schedule I to the Memorandum of Equipment Security Agreement is hereby deleted in its entirety and replaced with the attached Schedule I;

Except as amended hereby, the terms and conditions of such Memorandum of Equipment Security Agreement remain in full force and effect; and

This Amendment to Memorandum of Equipment Security Agreement may be executed in counterparts, each such counterpart shall be binding on both parties hereto, notwithstanding that both parties are not signatories to the same counterpart.






