

MEMORANDUM OF ASSIGNMENT OF LEASE AGREEMENT

This MEMORANDUM OF ASSIGNMENT OF LEASE AGREEMENT ("Assignment") is made and entered effective as of June 01, 2009 by and between The Andersons, Inc. ("Assignor") and Wells Fargo Equipment Finance, Inc. ("Assignee").

WHEREAS, The Andersons, Inc., as Lessor, and Consolidated Grain and Barge Co, as Lessee, have heretofore entered into that certain The Andersons Rail Operating I LLC Full Service Lease Agreement dated effective December 1, 2006, and Rider Deal #R01334 dated September 16, 2008 (collectively, the "Lease") pertaining to the rail cars described therein ("Equipment").
