
Memorandum of Schedule No. 6 dated ^{October 7} ~~August~~ _____, 2009, and effective as of July 1, 2009, to a Lease Agreement made and entered into as of May 16, 2000 by and between Greenbrier Leasing Company LLC, an Oregon limited liability company, formerly known as Greenbrier Leasing Corporation ("Lessor") and Ferrocarril Mexicano, S.A. de C.V., a Mexican corporation ("Lessee").

WITNESSETH:

1. Lessor has agreed to furnish to Lessee, and the Lessee has agreed to lease from Lessor, fifty (50) 60-foot, Plate G, 286,000 GRL boxcars with two (2) 8-foot plug doors, bearing marks and numbers as set forth on the attached Rail Equipment List.




