

WITNESSETH:



The Lessor and Lessee have amended that certain lease agreement dated August 1, 1991, relating to boxcars (the "Lease"), as more specifically described in the MEMORANDUM OF LEASE which was filed with the Interstate Commerce Commission and recorded in Recordation File No. 19531, by deleting Car No. PAL 701180 from the list of cars covered by the Lease.

The execution and delivery of this AMENDMENT TO MEMORANDUM OF LEASE is not intended to and shall not change, modify, amend or enlarge the provisions of the Lease (including modifications thereto executed by Lessee and Lessor, whether or not recorded with the Interstate Commerce Commission or the Surface Transportation Board). The Lessor and Lessee agree that this AMENDMENT TO MEMORANDUM OF LEASE shall be recorded with the Surface Transportation Board, successor to the recordation responsibilities of Interstate Commerce Commission pursuant to 49 U.S.C. Section 11301 (1994 and Supp. II 1996).
