


TERMINATION AND RELEASE OF SECURITY INTEREST

First Victoria National Bank ("First Victoria"), for good and valuable consideration the receipt and sufficiency of which is acknowledged, terminates and releases its rights and interests (including without limitation any security interests, liens, chattel mortgages, and other rights and interests as secured party) in and to, or pursuant to, any or all of the following: (i) thirty-seven (37) open top hoppers bearing the reporting marks and numbers ITGX 9500-9503 and 9505-9537 inclusive and one hundred-fifteen (115) covered hoppers railroad cars bearing the reporting marks and numbers ITGX 12600-12714 inclusive (the "Cars"); (ii) Railroad Car Lease Agreement, No. ITG-2359, dated 11/01/90, between ITG, Inc. and IMC Fertilizer, Inc., and related Riders No. Seven dated 02/15/00, Five dated 03/01/98 and Six dated 04/01/99; and (iii) Security Agreement dated 02/20/96 and amendments dated 04/22/96 and 05/07/96 and Collateral Assignment of Lease Agreement dated 02/20/96, each from ITG, Inc. in favor of First Victoria National Bank.

Memoranda of First Victoria's rights and interests with respect to the Cars as secured party have been recorded with the Surface Transportation Board under Recordation Nos. 19957 and 19958. Without limiting the generality of the foregoing, First Victoria releases and terminates its rights and interests covered by those memoranda.


