

## ASSIGNMENT OF MEMORANDUM OF LEASE AGREEMENT

THIS ASSIGNMENT OF MEMORANDUM OF LEASE AGREEMENT is made and entered into as of September 29, 2000, by and between LASALLE NATIONAL LEASING CORPORATION ("Assignor") and HSBC BUSINESS CREDIT (USA) INC. ("Assignee").

Assignor and Elgin, Joliet and Eastern Railway Company ("Lessee") have heretofore entered into that certain Memorandum of Lease Agreement dated as of September 1, 2000 (the "Memorandum of Lease Agreement") pertaining to the railcars described therein (the "Railcars") leased pursuant to the Lease (as such term is defined therein). The Memorandum of Lease Agreement has been filed with the Surface Transportation Board pursuant to 49 U.S.C.11301 and 49 CFR 1177 on September 12, 2000.




