



MEMORANDUM OF TERMINATION AND
RELEASE OF LEASE AGREEMENT

SURFACE TRANSPORTATION BOARD

THIS MEMORANDUM OF TERMINATION AND RELEASE OF LEASE AGREEMENT (this "Memorandum of Termination") is made and entered as of November 30, 2000, between ALLFIRST LEASING CORPORATION (formerly known as First Maryland Leasecorp), a Maryland corporation (the "Lessor") and NORFOLK SOUTHERN RAILWAY COMPANY, a Virginia corporation (the "Lessee"), with reference to the following:

1. Pursuant to the Lease Agreement dated as of October 14, 1993 between Railcar, Ltd., a Georgia corporation ("Railcar") and Lessee (the "Lease"), Railcar leased certain railroad freight car equipment more specifically described in Exhibit A attached hereto and incorporated herewith (the "Cars") to Lessee. A memorandum of the Lease was recorded with the Surface Transportation Board (formerly, the Interstate Commerce Commission) ("STB") pursuant to 49 U.S.C. §11301 and assigned recordation number 18695.


2. Pursuant to the Master Assignment Agreement dated as of July 16, 1996 between Railcar and Lessor (the "Assignment"), Railcar assigned to Lessor and Lessor purchased, accepted and assumed, all of Railcar's rights and obligations with respect to the lease arrangement, including all of Railcar's right, title and interest in and to the Cars and the Lease. A memorandum of the Assignment was recorded with the STB pursuant to 49 U.S.C. §11301 and assigned recordation number 18695-B. The Bill of Sale pursuant to which the Cars were sold by Railcar to Lessor was recorded with the STB and assigned recordation number 20185.

3. The Lease is hereby terminated.

4. Lessor hereby releases its right, title and interest in and to the Cars and the Lease.

5. This Memorandum of Termination may be signed in counterparts or duplicate copies, and any signed counterpart or duplicate copy shall be equivalent to a signed original for all purposes.
