

MEMORANDUM OF RAILCAR LEASE

KNOW ALL PERSONS BY THESE PRESENTS THAT:

WHEREAS, the Lessor and the Lessee entered into that certain Master Railcar Lease (the "Lease") dated as of January 24, 2001 covering the equipment listed on Schedule A hereto (the "Equipment").
