TERMINATION OF LOCOMOTIVE OPERATING LEASE AGREEMENT UNDER RECORDATION NO. 18646 SURFACE TRANSPORTATION BOARD

THIS TERMINATION is made as of this 31st day of January, 2001, by Deutsche Credit Corporation ("Lender").

WHEREAS, Precision National Corporation ("PNC") and Burlington Northern Railroad Company entered into that certain Locomotive Operating Lease Agreement dated as of September 17, 1993 (the "Lease"), recorded on January 7, 1994, with the Surface Transportation Board (the successor to the Interstate Commerce Commission) under Recordation Number 18646, which such Lease has been terminated; and

WHEREAS, Lender and PNC entered into that certain Assignment of Lease and Rents dated as of September 17, 1993, recorded on January 7, 1994, with the Surface Transportation Board under Recordation Number 18646-A.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is acknowledged, Lender hereby terminates, releases and discharges any and all assignments, liens and security interests granted to it under the aforesaid documents and acknowledges that the Lease has been terminated. Any such assignments, liens and security interests shall be forever terminated upon the filing of this Termination with the Surface Transportation Board, at which time all of Lender's right, title and interest in and to any equipment covered under the aforesaid documents shall be null and void.


