MEMORANDUM OF INDENTURE SUPPLEMENT NO. B2

Memorandum of Indenture Supplement No. B2 made and entered into on September 26, 2001 by and between Wells Fargo Bank Northwest, N.A., a national banking association, as indenture trustee ("*Indenture Trustee*"), and Wilmington Trust Company, a Delaware banking corporation, not in its individual capacity but solely as owner trustee ("*Owner Trustee*").

WITNESSETH




