AMTRAK LEASE (01-AS)

MEMORANDUM OF SUBLEASE SUPPLEMENT OF RAILROAD EQUIPMENT (AMTRAK SUBLEASE NO. 01-AS) effective as of October 5, 2001, between, NATIONAL RAILROAD PASSENGER CORPORATION (also known as Amtrak), a corporation organized under the Rail Passenger Service Act and the laws of the District of Columbia (the "Lessor"), and EXPRESSTRAK, L.L.C., a Delaware limited liability company (the "Lessee"). Capitalized terms used herein which are not defined herein shall have their respective meanings ascribed thereto in the Sublease (referred to below).

WHEREAS, the Lessor and the Lessee have entered into that certain Sublease of Railroad Equipment (AMTRAK SUBLEASE NO. 01-AS) dated as of May 15, 2001 (the "Sublease") and that certain Sublease Supplement No. 9 (AMTRAK SUBLEASE NO. 01-AS) dated October 5, 2001 ("Supplement No. 9") (the terms of each of which are incorporated herein by reference), covering the railroad equipment identified in Schedule A hereto, bearing the equipment numbers of the Lessee shown in said Schedule A including all additions and alterations thereof, replacements thereof and substitutions therefor;

WHEREAS, ORIX Financial Services, Inc., a New York corporation ("ORIX") and Lessor, as lessee thereunder, have entered into that certain Lease of Railroad Equipment (AMTRAK LEASE NO. 01-A) dated as of May 15, 2001 (the "Lease") and that certain Lease Supplement No. 9 (AMTRAK LEASE NO. 01-A) dated as of October 5, 2001 ("Lease Supplement No. 9"), covering the Equipment and all additions and alterations thereof, replacements thereof and substitutions therefor;

WHEREAS evidence of the Lease and Lease Supplement No. 9 has been recorded with the United States Surface Transportation Board pursuant to Section 11301 of Title 49 of the United States Code under recordation number 23505;

WHEREAS pursuant to the terms of the Lease, the Lessor is collaterally assigning to ORIX, its interest in and to the Sublease and Supplement No. 9 as security for Lessor's obligations under the Lease;

WHEREAS, the Sublease and Supplement No. 9 shall be effective as of the Closing Date (as defined in the Sublease); and

WHEREAS, this memorandum may be executed in any number of counterparts, each executed counterpart constituting an original but all together only one such memorandum.


