

H.J. Shands, Jr. ("Assignor," whether one or more), for good and valuable consideration, the receipt and sufficiency of which is acknowledged, executes this instrument. Assignor grants, transfers and assigns to DLCO I, Ltd. (hereinafter sometimes referred to as "Assignee"):

1. All of Assignor's interest in that certain lease between H.J. Shands, Jr. and Diboll Leasing Company (the "Lease"), and recorded by the Interstate Commerce Commission on June 5, 1979 as ICC number 10447. The boxcar(s) covered by said lease were recorded by the Interstate Commerce Commission ("ICC") on June 5, 1979 for the previous owner H.J. Shands, Jr. and were labeled with the ICC recordation number 10435; and
2. All of Assignor's interest in that certain service contract executed between H.J. Shands, Jr. and Texas Southeastern Railroad Company

All of the aforementioned hereinafter sometimes referred to as the "Property." Such Assignment is made subject to the following provisions:

- ◆ **WARRANTY.** Assignor expressly warrants that Assignor has good title to the Property conveyed by this Assignment, that the Property is free from prior encumbrances of any kind, that Property is not subject to any third party claims now pending or anticipated and that property constitutes 100% of the property interest owned by the Assignor.

- ◆ THE TSE LEASE. The Assignor understands that the Texas Southeastern Railroad Company ("TSE") has an interest in this Property because of a lease agreement between H.J. Shands, Jr. and the Diboll Leasing Company covering the same Property. Assignor agrees that it will execute any documents and take any actions to insure the continued TSE lease of the Property from the Diboll Leasing Company. Assignee agrees that if this Assignment has the effect of canceling, voiding, or adversely and materially impacting the lease between Diboll Leasing Company and TSE, then within 30 days of the execution of this lease or notice to the TSE (whichever is later), Assignor has the right, but not the obligation, to revoke this Assignment.
- ◆ COVENANTS OF LEASE. Assignee agrees to abide by the terms of the Lease upon the execution of this Assignment.
- ◆ COVENANTS OF SERVICE CONTRACT. Assignee agrees to abide by the terms of the Service Contract executed between H.J. Shands, Jr. and Texas Southeastern Railroad Company ("TSE") upon the execution of this Assignment.
- ◆ EXISTING LIABILITIES. All those liabilities as an owner of the Property accrued prior to this Assignment are retained by Assignor.
- ◆ ASSIGNORS DUTIES. Assignor agrees to take any and all actions necessary to consummate the conveyance of the Property. Furthermore, Assignor agrees to testify or take any other actions necessary to insure the validity of this Assignment and to protect the ownership interests of the Property by the Assignee.
- ◆ INDEMNITY. Assignee agrees to indemnify Assignor for any liability to third parties arising out of or in connection with the Property after the effective date of this Assignment. No indemnities of any nature or kind run from Assignor to Assignee in connection with this Assignment except those liabilities accrued before this Assignment.
- ◆ BINDING EFFECT. This Assignment and all of its terms and conditions are binding on Assignor and Assignor's heirs, devisees, personal representatives, successors and assigns, and on Assignee and its successors and assigns.






