MEMORANDUM OF INDENTURE SUPPLEMENT (2001B-2) NO. 1, made and entered into October 31, 2001 by and between ALLFIRST FINANCIAL CENTER NATIONAL ASSOCIATION, a national banking association, not in its individual capacity, but solely as Owner Trustee under the Trust Agreement (2001B-2) dated as of October 15, 2001, as Owner Trustee (the "Owner Trustee") and WILMINGTON TRUST COMPANY, a Delaware banking corporation, as Indenture Trustee (the "Indenture Trustee").

WITNESSETH:

1. The undersigned have entered into that certain Indenture and Security Agreement (2001B-2), dated as of October 15, 2001 (the "Indenture"), by which the Owner Trustee has granted a security interest to the Indenture Trustee in order to secure the Owner Trustee's performance of certain obligations as described in the Indenture.

2. A memorandum of said Indenture is being recorded with the Surface Transportation Board concurrently herewith pursuant to Section 11301 of Title 49 of the United States Code.

3. 
