Memorandum of Head Lease Agreement (BSDA 2001-F1), made and entered into on August 30, 2001 by and between Bi-State Development Agency of the Missouri-Illinois Metropolitan District (the "**Head Lessor**") and BSDA 2001-F1 Statutory Trust (the "**Head Lessee**").
