
This AMENDMENT NO. 1 TO MEMORANDUM OF SCHEDULE NO. 003 TO THE RAILROAD EQUIPMENT MASTER LEASE ("Amendment No. 1 to Memorandum of Schedule No. 3") entered into this 8<sup>th</sup> day of October, 2002, is intended to evidence the schedule dated as of September 30, 2002 (the "Schedule No. 3"), between JOSEPH TRANSPORTATION SERVICES, INC., a Delaware corporation ("Lessor"), and OHIO CENTRAL RAILROAD, an Ohio corporation ("Lessee"), for the purpose of satisfying the requirements of recordation with the Surface Transportation Board under Section 49 of U.S.C. 11301.
