MEMORANDUM OF PARTIAL ASSIGNMENT OF MASTER LEASE

(EL-MO II TRUST NO. 2002-F)

Memorandum of Partial Assignment of Master Lease effective December 18, 2002 by and between El-Mo Leasing II Corporation, a Delaware corporation ("Assignor") and Wilmington Trust Company, a Delaware banking corporation, as Owner Trustee ("Assignee").

WITNESSETH

The Assignor is Lessor under a Master Lease dated May 1, 2000 with Union Pacific Railroad Company as Lessee. Supplement No. 4 to such memorandum was recorded with the STB on August 30, 2002 under Recordation Number 22960-II with respect to SD70M locomotives bearing road numbers 5000 through 5126 inclusive.


