

**RELEASE OF LIEN

SURFACE TRANSPORTATION BOARD

THIS RELEASE OF LIEN OF SECURITY AGREEMENT (this "Release") is given as of this 23rd day of December, 2002, by WACHOVIA BANK NATIONAL ASSOCIATION, formerly known as SIGNET BANK/MARYLAND (the "Secured Party"), and CRYO-TRANS, INC. (the "Debtor"), witnesseth:

WHEREAS, MARVIN H. WEINER, as lender (the "Assignor"), and the Debtor entered into that certain Security Agreement dated as of May 5, 1991, bearing Interstate Commerce Commission ("ICC") Recordation No. 17322 (the "Agreement") relating to, among others, certain box cars more specifically described on Schedule 1 attached hereto (the "Released Railcars"); and

WHEREAS, pursuant to a Three-Party Assignment and Security Agreement recorded May 22, 1991 and bearing ICC Recordation No. 17322-A, the Assignor assigned to SIGNET BANK/MARYLAND his interests in the Agreement; and

WHEREAS, WACHOVIA BANK NATIONAL ASSOCIATION was formerly known as SIGNET BANK/MARYLAND; and

WHEREAS, ICC is now known as the "Surface Transportation Board" ("STB").

NOW, THEREFORE, in consideration of the premises contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto submit the following:

1. The Secured Party releases any lien against the Released Railcars created by or arising out of the Agreement.
2. This Release shall be recorded with the STB so as to record the release of the lien against the Released Railcars constituted by the Agreement.




