

**MEMORANDUM OF SECURITY AGREEMENT AND ASSIGNMENT**

This Memorandum of Security Agreement and Assignment is dated as of December 1, 2002 by and between Tucker Commercial Lease Funding, LLC ("TUCKER FUNDING"), as transferor, and Bank of America Lease Equipment Trust 2002-A (the "TRUST"), as assignee.

1. Pursuant to a Pooling and Servicing Agreement, dated as of December 1, 2002, among the TRUST, as issuer, TUCKER FUNDING, as transferor, and Banc of America Leasing & Capital, LLC ("BALCAP"), as servicer, (i) TUCKER FUNDING agreed to transfer all of its right, title and interest in, to and under certain contracts identified in Schedule 1 to the TRUST and the TRUST has agreed to accept the transfer of such contracts, and (ii) TUCKER FUNDING agreed to grant a security interest in certain equipment identified in Schedule 2 to the TRUST.






