MEMORANDUM OF PARTIAL ASSIGNMENT OF MASTER LEASE

(EL-MO II TRUST NO. 2002-D)

Memorandum of Partial Assignment of Master Lease effective May 21, 2003 by and between El-Mo Leasing II Corporation, a Delaware corporation ("Assignor") and Wilmington Trust Company, a Delaware banking corporation, as Owner Trustee ("Assignee").


WITNESSETH

The Assignor is Lessor under a Master Lease dated May 1, 2000 with Union Pacific Railroad Company as Lessee. A memorandum of such Master Lease was recorded with the Surface Transportation Board (the "STB") on June 20, 2000 under Recordation Number 22960 with respect to SD70M locomotives bearing road numbers 4000 through 4274 inclusive. Supplement No. 1 to such memorandum was recorded with the STB on December 20, 2000 under Recordation Number 22960-I with respect to SD70M locomotives bearing road numbers 4275 through 4284 inclusive. Supplement No. 2 to such memorandum was recorded with the STB on March 27, 2001 under Recordation Number 22960-K with respect to SD70M locomotives bearing road numbers 4285 through 4709 inclusive. Supplement No. 3 to such memorandum was recorded with the STB on December 10, 2001 under Recordation Number 22960-X with respect to SD70M locomotives bearing road numbers 4710 through 4999 inclusive. Supplement No. 4 to such memorandum was recorded with the STB on August 30, 2002 under Recordation Number 22960-II with respect to SD70M locomotives bearing road numbers 5000 through 5126 inclusive. Supplement No. 5 to such memorandum was recorded with the STB on March 24, 2003 under Recordation Number 22960-OO with respect to SD70M locomotives bearing road numbers 3874 through 3973 inclusive.

The undersigned have entered into that certain Collateral Assignment of Lease Supplements dated as of May 21, 2003, whereby the Assignor has assigned to Assignee as security the rights of Assignor under Lease Supplement No. 53 to the Master Lease, pursuant to which the SD70M locomotives listed on Exhibit A hereto were made subject to the Master Lease.
