

MEMORANDUM OF ASSIGNMENT AND AGREEMENT

This Memorandum of Assignment and Agreement is dated as of May 30, 2003 by and between G FINANCE HOLDING CORP., assignee of Deutsche Financial Services Corporation, formerly known as Deutsche Credit Corporation ("G FINANCE"), the assignor, and LASALLE NATIONAL LEASING CORPORATION ("LASALLE"), the assignee.

WITNESSETH:

1. G FINANCE, as lessor, entered into a Lease Agreement (the "Lease") dated as of July 19, 1991 with BASF Corporation ("BASF"), as lessee, to lease 10 covered hopper cars numbered DBCX 385-394, inclusive (the "Equipment") to lessee. A Memorandum of Lease Agreement dated as of July 19, 1991 was recorded on October 28, 1991 at the Interstate Commerce Commission (the "ICC") under Recordation No. 17573.

2. In consideration of the premises and the agreements herein contained and other good and valuable consideration, the receipt of which is hereby acknowledged, G FINANCE is, effective as of the date hereof: (a) assigning to LASALLE, all rights, title, interests, and obligations of G FINANCE in, under and to the Lease, and LASALLE is accepting all of the same, in each such case to the extent attributable to the period commencing on and continuing after the consummation of such assignment and acceptance on June 1, 2003 at 12:01 a.m. Eastern Daylight Time; and (b) selling the Equipment to LASALLE, and LASALLE shall be the owner of the Equipment and G FINANCE shall have no interest or authority of any nature regarding the Equipment. G FINANCE is not transferring, and LASALLE is not assuming, any obligations or liabilities of G FINANCE under or in any way related to the Lease.

3. This Memorandum of Assignment and Agreement may be executed in any number of counterparts, each of which shall be an original, all of which when taken together shall constitute one agreement binding on all parties, notwithstanding that all parties are not signatories to the same counterpart.




