

INSTRUMENT OF PARTIAL SATISFACTION AND RELEASE OF SECURITY AGREEMENT (the "INSTRUMENT"), dated as of June __, 2003, by FINOVA CAPITAL CORPORATION ("FINOVA")

WITNESSETH

WHEREAS, by a Loan and Security Agreement ("Security Agreement"), dated as of June 17, 1998, between FINOVA, as Lender, ENVIRONMENTAL PROTECTION & IMPROVEMENT COMPANY, INC. ("EPIC"), as borrower, and COMPOST AMERICA HOLDING COMPANY, INC. ("CAHC"), as guarantor, EPIC pledged 150 Berwick Articulated Skeleton Container Rail cars numbered EPIX 91003-91072, inclusive, 91074-91146, inclusive, and 91148-91154, inclusive (the "Rail Equipment"), among other rail equipment, as collateral to FINOVA;

WHEREAS, a Memorandum of Loan and Security Agreement dated as of June 17, 1998 ("Memorandum") between FINOVA, as lender, EPIC, as borrower, and CAHC, as guarantor, representing the Security Agreement, was recorded at the Surface Transportation Board on June 17, 1998 in Recordation No. 21470; and

WHEREAS, FINOVA desires to execute this INSTRUMENT to evidence for the public record the satisfaction and release of the obligations of EPIC and CAHC and the termination of the rights of FINOVA to the Rail Equipment under the Security Agreement and Memorandum.

NOW, THEREFORE, in consideration of the premises:

FINOVA does hereby acknowledge and confirm for the public record the satisfaction and release of its security interest, and all rights and obligations arising under the Security Agreement and Memorandum with respect to the Rail Equipment.






