### SHORT FORM OF EQUIPMENT MORTGAGE AND PLEDGE AGREEMENT

This Short Form of Equipment Mortgage and Pledge Agreement is made and dated as of the 13<sup>th</sup> day of August, 2003 (this "**Short Form**"), by and between, **WASHINGTON METROPOLITAN AREA TRANSIT AUTHORITY**, a body corporate and politic created and existing under and by virtue of a compact between the State of Maryland, the Commonwealth of Virginia and the District of Columbia (the "**Mortgagor**") and having an address at 600 Fifth Street, NW, Washington, DC 20001 and **WMATA 2003 TRUST ICX A**, a Delaware statutory trust (the "**Mortgagee**"), having an address in care of Wilmington Trust Company, Rodney Square North, 1100 North Market Street, Wilmington, Delaware 19890-0001:

**A.** The Mortgagor desires to grant a security interest and lien as described below to Mortgagee, and Mortgagee desires to obtain such security interest and lien, on the terms and conditions set forth in that certain Equipment Mortgage and Pledge Agreement (WMATA-ICX-A), as of the date hereof (the "**Equipment Mortgage**"), between the Mortgagor and the Mortgagee, which by this reference is incorporated herein and made a part hereof as if set forth at length.

**B.** The Mortgagor and Mortgagee desire to record this Short Form in order to give constructive notice with the U.S. Surface Transportation Board of Mortgagee's security interest in the Equipment as defined below.

In consideration of the foregoing recitals, and for other good and allowable consideration, the receipt and sufficiency of which are hereby acknowledged, the Mortgagor and Mortgagee agree as follows:

1. **Property Subject to Equipment Mortgage:** Mortgagor hereby grants a mortgage, security interest in and lien upon the following: (a) the equipment described in Exhibit A attached hereto and incorporated herein by reference (the "**Equipment**"); (b) all rights, claims and causes of action, if any, that the Mortgagor may have against any Person in respect of the foregoing; and (c) all property received upon the sale, exchange, collection of any and all of the foregoing.

2. **Conflict With Equipment Mortgage:** In the event of any conflict between this Short Form and the Equipment Mortgage, the terms, covenants and conditions of the Equipment Mortgage shall control.

3. **Counterparts:** This Short Form may be executed in one or more counterparts, but there shall be only one original. Signature pages may be detached from multiple separate counterparts and attached to a single counterpart so that all signature pages are physically attached to the same instrument, which shall be the original of this Short Form.






