THIS MEMORANDUM OF RAILCAR LEASE dated as of this 14TH day of APRIL, 2003, is made by THE CIT GROUP/EQUIPMENT FINANCING, INC., a Delaware corporation, with an address at 1211 Avenue of the Americas, 20th Floor, New York, New York 10036 (the "Lessor"), and ST MARYS CEMENT INC. (U.S.), a Delaware corporation, with an address at 250 Jefferson Ave., , Cleveland, OH 44113 (the "Lessee" and, together with the Lessor, the "Parties").

KNOW ALL PERSONS BY THESE PRESENTS THAT:

WHEREAS, the Lessor and the Lessee entered into that certain Master Railcar Lease (the "Lease") dated as of March 28, 2002 covering the equipment described therein and with respect to which a Memorandum of Railcar Lease was filed with the Surface Transportation Board ("STB") on 4/14/03 and given Recordation Number 24409.
