**MEMORANDUM OF ASSIGNMENT**  
(Surface Transportation Board)

THIS MEMORANDUM OF ASSIGNMENT (this "Memorandum") dated as of July 7, 2003 is by and between MANUFACTURERS AND TRADERS TRUST COMPANY (successor in interest to Allfirst Bank), a New York chartered bank ("M&T Bank") and M&T CREDIT CORPORATION, a New York corporation ("M&T Credit").

The parties to this Memorandum hereby acknowledge and confirm the following:

A. M&T Bank, as lessor and debtor, as appropriate, is a party to certain lease and security documents (the "M&T Documents") recorded at the Surface Transportation Board pursuant to the provisions of 49 U.S.C. Section 11301.

B. M&T Bank, as assignor, and M&T Credit, as assignee, are parties to that certain Assignment Agreement and Acceptance Agreement, each dated as of July 7, 2003, pursuant to which M&T Bank has assigned to M&T Credit, and M&T Credit has accepted from M&T Bank, M&T Bank's interest, rights and obligations in the M&T Documents (the "Assignment of M&T Bank's Interest").
