

**MEMORANDUM OF INDENTURE SUPPLEMENT NO. 4  
(BOHLI/STALEY TRUST 2003A LLT)**

SURFACE TRANSPORTATION BOARD

MEMORANDUM OF INDENTURE SUPPLEMENT NO. 4, made and entered into as of September 26, 2003 by and between BOHLI/Staley Trust 2003A LLT, acting through U.S. Bank Trust National Association, a national banking association, not in its individual capacity, but solely as owner trustee ("Owner Trustee") and Wells Fargo Bank Northwest, National Association, as Indenture Trustee ("Indenture Trustee").

**WITNESSETH:**

1. The undersigned have entered into that certain Trust Indenture and Security Agreement (BOHLI/Staley Trust 2003A LLT), dated as of January 31, 2003 (the "Trust Indenture"), by which the Owner Trustee has granted a security interest in certain railroad equipment bearing reporting marks as listed on Exhibit A attached hereto to the Indenture Trustee in order to secure the Owner Trustee's performance of its obligations as described in the Trust Indenture.


