

THIS MEMORANDUM OF PARTIAL ASSIGNMENT dated as of September 26, 2003 is between FIRST UNION RAIL CORPORATION, a North Carolina corporation ("FURC"), and MANUFACTURERS AND TRADERS TRUST COMPANY (as successor to Allfirst Bank), a New York bank ("M&T").

The parties to this Memorandum hereby acknowledge and confirm the following:

A. FURC, as lessor has leased the Locomotives under that certain Equipment Lease Agreement dated as of October 25, 2000 (as amended, modified, extended, supplemented, restated and/or replaced from time to time, the "Lease") to Norfolk Southern Railway Company.

B. The Lease was recorded with the Surface Transportation Board on October 27, 2000 under recordation No. 23204.

C. FURC and M&T are parties to that certain Assignment and Assumption Agreement dated March 15, 2002 pursuant to which FURC has assigned to M&T certain rights and obligations of "Lessor" under the Lease with respect to such locomotives identified on Schedule I attached hereto (the "Locomotives").


