RELEASE

SURFACE TRANSPORTATION BOARD

This Release is executed as of September 25, 2003, by The David J. Joseph Company, a Delaware corporation.

WHEREAS, The David J. Joseph Company ("Lessor") and Arkansas Power & Light Company ("Lessee") were parties to that certain lease dated February 10, 1994 ("Lease"). One hundred and fourteen (114) railcars bearing reporting marks and numbers DJJX 7000-7113, inclusive, ("Railcars") were the subject of the Lease. The Lease was recorded at the Interstate Commerce Commission ("ICC") on June 3, 1994 under Recordation No. 18832.

WHEREAS, Lessor sold the Railcars and assigned the Lease to The First National Bank of Maryland ("FNBMD") on May 31, 1994. The Bill of Sale dated May 31, 1994, was filed with the ICC on June 3, 1994 under Recordation No. 18831.

WHEREAS, Lessor assigned the Lease to FNBMD on May 31, 1994, which was evidenced by filing a Memorandum of Assignment and Assumption Agreement dated as of May 31, 1994 with the ICC on June 3, 1994 under Recordation No. 18832-A.

WHEREAS, at the expiration of the Lease, Lessor purchased back the Railcars from FNBMD under that certain Purchase and Sale Agreement ("P&SA") dated January 30, 1997.

NOW THEREFORE, in consideration of the premises and mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt of which is hereby acknowledged, Joseph and USB agree as follows:

1. The Lease holding Recordation No. 18832, the Memorandum of Assignment and Assumption Agreement holding Recordation No. 18832-A, and the Bill of Sale holding Recordation No. 18831 are hereby terminated. The David J. Joseph Company ("DJJ") hereby (a) releases all rights, interests or claims to, and all liens and encumbrances upon, the Railcars, and (b) represents and warrants that such Railcars may be sold, leased or otherwise transferred by DJJ free and clear of any further interest of the Lessee or FNBMD under the P&SA and without the consent of FNBMD.

2. DJJ has executed this Release for purposes of memorializing of record the agreements set forth herein.

IN WITNESS WHEREOF, DJJ has caused this Release to be duly executed by their officer duly authorized as of the date and year first above written.


