**TRUST INDENTURE SUPPLEMENT NO. 4
(GARC III Trust No. 99-B)**

This Indenture Supplement No. 4 (GARC III Trust No. 99-B), dated January 31, 2003 (this "Indenture Supplement"), of GARC III 99-B Railcar Trust by Wilmington Trust Company, not in its individual capacity but solely as trustee (the "Owner Trustee") under the Trust Agreement (GARC III 99-B), dated as of September 1, 1999 (the "Trust Agreement"), between Wilmington Trust Company and General Foods Credit Corporation, as owner participant;

WITNESSETH:

WHEREAS, the Trust Indenture and Security Agreement (GARC III 99-B) dated as of September 1, 1999 (the "Indenture"), between the Owner Trustee and US Bank National Association as Indenture Trustee (the "Indenture Trustee"), provides for the execution and delivery of Indenture Supplements recording any change in the reporting marks of any Unit covered by the Lease; and

WHEREAS, the Lease has been amended to change the reporting marks of the Equipment as described on Schedule A attached hereto and made a part hereof; and

NOW, THEREFORE, the reporting marks of certain Units of the Equipment described in the Lease are hereby changed as reflected on said Schedule.




