**Payoff Instruction and Release Re:--Trinity Rail Leasing Trust II sale of  
Railcars and related Leases to Trinity Rail Leasing III L.P.**

November 12, 2003

The undersigned, Credit Suisse First Boston, New York Branch, is executing this instrument in its capacity as Agent (in such capacity, the "Agent") under the Warehouse Loan Agreement, dated as of June 27, 2002 (as amended from time to time, the "Warehouse Loan Agreement"), among Trinity Industries Leasing Company ("TILC"), Trinity Rail Leasing Trust II ("TRLT-II"), the Lenders party thereto from time to time, and the Agent, as well as the related Security Agreement, dated as of June 27, 2002 (as amended from time to time, the "Security Agreement"), between TRLT-II and the Agent.

The Agent currently holds a security interest granted by TRLT-II in the railcars described on Schedule 1 hereto (such railcars, together with TRLT-II's right, title and interest in all components, parts and accessions to such cars and in all equipment attached or related thereto, being the "Railcars") and the related leases thereof described on Schedule 2 hereto (the "Leases") (the Railcars and Leases being the "Assets"), which TRLT-II has granted to the Agent under the Security Agreement to secure obligations under the Warehouse Loan Agreement. The Agent consents to TRLT-II's disposition of the Assets by sale on the date hereof to Trinity Rail Leasing III L.P. (together with its successors and assigns, if any, "Trinity LP") pursuant to the Transfer and Assignment Agreement, dated as of November 12, 2003, between TRLT-II, as seller and Trinity LP, as purchaser: The Agent hereby confirms and agrees, without recourse to or warranty by the Agent or the Secured Parties (as defined in the Security Agreement), for the benefit of TRLT-II and Trinity LP, that effective upon delivery on the date hereof by wire transfer in immediately available funds of the amount specified on Exhibit A attached hereto, to the deposit account identified on Exhibit A hereto, all of the Agent's right, title and interest in and to the Assets, whether held pursuant to the Security Agreement or otherwise, is released and of no further effect. The Agent agrees that immediately upon receipt of such funds, it will confirm such receipt to Trinity LP and its counsel and TRLT-II and the Agent further irrevocably agrees thereupon forthwith to authorize Trinity LP to file UCC financing statement partial releases or terminations and releases of Surface Transportation Board and Registrar General of Canada filings, which have been duly executed and delivered by the Agent (at the expense of TRLT-II), as shall be necessary or desirable to reflect such releases or terminations.




