MEMORANDUM OF ASSIGNMENT AND ASSUMPTION AGREEMENT

THIS MEMORANDUM OF ASSIGNMENT AND ASSUMPTION AGREEMENT, dated as of this 17th day of December, 2003, is made by The Clarkesville Leasing Partnership, LLP, a Delaware limited liability partnership, with an address c/o Babcock & Brown Rail Management LLC, 230 Park Avenue, 32nd Floor, New York, NY 10169 (the "Partnership"), Lloyds TSB Equipment Leasing (No. 5) Limited, a limited liability company incorporated under the laws of England and Wales, c/o Lloyds TSB Leasing Limited, 25 Gresham Street, London EC2V 7HN, United Kingdom ("LEL") and North America Rail Leasing #2 LLC (d/b/a Babcock & Brown Rail Leasing), a Delaware limited liability corporation, with an address at 230 Park Avenue, 32nd Floor, New York, NY 10169 (the "Head Lessee" and, together with the Partnership and LEL, the "Parties").

KNOW ALL PERSONS BY THESE PRESENTS THAT:

WHEREAS, the Partnership, LEL and the Head Lessee entered into that certain Assignment and Assumption Agreement dated as of December 17, 2003 (the "Assignment") covering the equipment listed on Schedule A hereto (the "Equipment") and, in respect of the Equipment, the Lease of the Equipment and the prior assignment of the Lease;

WHEREAS, the Parties wish to show for the public record the existence of the aforesaid Assignment, and the respective interests therein of the Parties and accordingly the Parties have caused this memorandum to be executed by their respective duly authorized officers, as of the date first above written.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged by each of the Parties, by this instrument the Partnership hereby assigns to the Head Lessee all of the Partnership's rights and obligations, except certain retained obligations, under the Lease and the prior assignment of the Lease and confirms the terms and conditions of the Assignment, and the Head Lessee confirms and accepts such terms and conditions, which are incorporated by reference as if fully set forth herein.
