AMENDED MEMORANDUM OF MORTGAGE (TITLE MORTGAGE)
SURFACE TRANSPORTATION BOARD

Amended Memorandum of Mortgage (Title Mortgage), made and entered into as of December 19, 2003 by **BBRM TITLE HOLDING SPC #2 LLC**, as mortgagor under the Title Mortgage referred to below ("**Mortgagor**"), in favor of **LLOYDS TSB EQUIPMENT LEASING (NO. 5) LIMITED**, as mortgagee under the Title Mortgage referred to below ("**Mortgagee**") which amends (i) the Memorandum of Mortgage (Title Mortgage), made and entered into as of August 7, 2003 by Mortgagor in favor of BBRM Sub #1 LLC (the "**Original Memorandum of Mortgage (BBRL II)**"), (ii) the Memorandum of Mortgage (Title Mortgage), made and entered into as of December 16, 2003 by Mortgagor in favor of BBRM Sub #1 LLC (the "**Original Memorandum of Mortgage (BBRL III)**"), and (iii) the Memorandum of Mortgage (Title Mortgage) made and entered into as of December 17, 2003 by Mortgagor in favor of Mortgagee (the "**Original Memorandum of Mortgage (INTOL V)**"). Terms used in this instrument have the meanings assigned thereto (whether by reference to another document or otherwise) in that certain Title Mortgage (COMBI I) dated as of December 19, 2003 (as amended, modified or supplemented, the "**Title Mortgage**") between Mortgagor and Mortgagee.

WITNESSETH:

The undersigned has entered into the Title Mortgage, by which it has granted a first priority security interest in all of its right, title and interest (i) in and to certain railroad equipment bearing reporting marks as listed on Exhibit A to each of the Original Memorandum of Mortgage (BBRL II), the Original Memorandum of Mortgage (BBRL III) and the Original Memorandum of Mortgage (INTOL V) and (ii) in, to and under each lease referred to on Exhibit B attached to each of the Original Memorandum of Mortgage (BBRL II), the Original Memorandum of Mortgage (BBRL III) and the Original Memorandum of Mortgage (INTOL V) to the Mortgagee in order to secure the obligations as described in the Title Mortgage.


