

RT SUBLEASE SUPPLEMENT No. 3

THIS RT SUBLEASE SUPPLEMENT No. 3 dated January 23, 2004, is between SANTA CLARA VALLEY TRANSPORTATION AUTHORITY (formerly known as Santa Clara County Transit District), a special district organized and existing under and by virtue of the laws of the State of California ("VTA"), and SACRAMENTO REGIONAL TRANSIT DISTRICT, a public corporation organized and existing under and by virtue of the laws of the State of California ("RT").

WHEREAS, VTA and RT have heretofore entered into the RT Sublease Agreement dated as of December 12, 2003 (the "RT Sublease"), which RT Sublease provides for the execution and delivery of RT Sublease Supplements in substantially the form hereof for the purpose of subleasing the Items of RT Equipment when delivered by VTA to RT in accordance with the terms thereof. All of the terms and provisions of the RT Sublease are hereby incorporated by reference in this RT Sublease Supplement No. 3 to the same extent as if fully set forth herein (including those terms providing that capitalized terms used therein and not otherwise defined therein shall have the meanings given such terms in Appendix A to the RT Sublease, and the rules of usage set forth therein shall apply thereto).

NOW, THEREFORE, in consideration of the premises and other good and sufficient consideration, and pursuant to Section 2 of the RT Sublease:

Section 1. VTA hereby delivers and subleases to RT, and RT hereby accepts and subleases from VTA, under the RT Sublease as herein supplemented, the Item(s) of RT Equipment described by running number and RT Equipment Lot in Schedule A hereto.

Section 2. RT Sublease Rent for such Item(s) of RT Equipment is set forth in Schedule VII to the RT Sublease under the column "RT Sublease Rent" and corresponding to the running number(s) for such Item(s) of RT Equipment.

Section 3. RT Stipulated Loss Values are in the amounts as set forth in Schedule V to the RT Sublease.


