LEASE SUPPLEMENT NO. 6

(Solvay Polymers Equipment Trust 1995)

THIS LEASE SUPPLEMENT NO.6 (this "Lease Supplement"), dated as of January 23, 2004, is entered into between WILMINGTON TRUST COMPANY, a Delaware banking corporation, not in its individual capacity, but solely as trustee under the Trust Agreement that creates the trust identified under the title hereof (the "Owner Trustee"), and SOLVAY POLYMERS, INC., a Delaware corporation ("Lessee").

WHEREAS, the Lessor and the Lessee have heretofore entered into the Lease to which this Lease Supplement is a supplement.

WHEREAS, the Lease provides for the execution and delivery of a Lease Supplement for the purposes set forth in Section 28(c) thereof.

NOW, THEREFORE, in consideration of the mutual terms and conditions contained herein and in the Lease, the parties hereto agree as follows:

1. Capitalized terms used but not otherwise defined herein (including those used in the foregoing recitals) shall have the meanings specified in Schedule X to the Participation Agreement dated as of September 1, 1995, among General Electric Capital Corporation, Wilmington Trust Company, in its individual capacity and as trustee under the Trust Agreement that creates the trust identified under the title hereof, Solvay Polymers, Inc., and others, as such Schedule X existed on the Closing Date and as such Schedule X shall have been amended to and including the date hereof, which Schedule X shall for all purposes constitute a part of this Lease Supplement.

2. On May 27, 2002 an Event of Loss occurred with respect to railcar AMCX 4560 ("AMXC 4560"). On December 6, 2001, an Event of Loss occurred with respect to railcar AMCX 4595 ("AMCX 4595"). On December 12, 2001 an Event of Loss occurred with respect to railcar AMCX 4597 ("AMCX 4597"). For purposes of this Lease Supplement, AMCX 4560, AMCX 4595 and AMCX 4597, all as further described in Schedule I hereto, are collectively referred to as the "Lost Equipment".

3. Lessor acknowledges that, pursuant to Section 28(a)(i) of the Lease, Lessee has paid the amount of \$67,650.60 as the Stipulated Loss Value of AMCX 4560 and has otherwise fulfilled its SLV Obligations with respect thereto.

4. Lessor acknowledges that, pursuant to Section 28(a)(i) of the Lease, Lessee has paid the amount of \$67,650.60 as the Stipulated Loss Value of AMCX 4595 and has otherwise fulfilled its SLV Obligations with respect thereto. Lessor also acknowledges that, pursuant to Section 4(e) of the Lease, Lessee has paid an additional \$2,037.34 as interest at the Past Due Rate.

5. Lessor acknowledges that, pursuant to Section 28(a)(i) of the Lease, Lessee has paid the amount of \$67,435.57 as the Stipulated Loss Value of AMCX 4597 (\$67, 650.60 less

the credit for overpayment of advance rent on AMCX 4597 of \$215.03), and has otherwise fulfilled its SLV Obligations with respect thereto.

6. Lessor and Lessee agree that:

(i) all right, title and interest of Lessor in and to the Lost Equipment is hereby assigned, sold and transferred to Lessee (subject, in all respects, to the provisions of the Bill of Sale of even date herewith with respect to the Lost Equipment);

(ii) the Lost Equipment is released and discharged from the provisions of the Lease;

(iii) Lessee has no further obligation to pay any Rent with respect to the Lost Equipment; and

(iv) Schedule II hereto sets forth revised Basic Rent Factors and Basic Rent amounts (in United States dollars) for the remaining Equipment covered under Lease Supplement Number 3, dated September 27, 1996.

7. This Lease Supplement may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all such counterparts shall together constitute but one and the same instrument.

8. This Lease Supplement constitutes a supplement to, and a part of, the Lease, and the Lease, as hereby supplemented, remains in full force and effect.


9. This Lease Supplement shall in all respects be governed by and construed in accordance with the laws of the State of New York without regard to principles of conflicts of law.


