TERMINATION OF LEASE AGREEMENT

SURFACE TRANSPORTATION BOARD

THIS TERMINATION OF LEASE AGREEMENT is made and entered into as of April 26, 2004 by and between ORIX Aircraft Corporation ("*Lessor*") and BN Leasing Corporation ("*Lessee*").

1. Lessor has heretofore leased to Lessee certain railroad equipment set forth on Schedule 1 attached hereto pursuant to Lease Agreement No. 2 dated as of April 18, 1990 (as supplemented and amended, the "*Lease*"), a Memorandum of which was duly recorded with the Surface Transportation Board (as successor to the Interstate Commerce Commission) on April 24, 1990 at 12:05 p.m. under Recordation Number 16841. Capitalized terms used herein without definition have the meanings assigned to them in the Lease.

2. The Lease is terminated effective as of the date hereof with respect to the units of railroad equipment set forth on Schedule 1 attached hereto (the "*Equipment*") pursuant to the provisions of the Lease. The Equipment represents all of the equipment subject to the Lease.

3. This Termination of Lease Agreement shall neither impair nor terminate the rights and obligations of the parties under the Lease which expressly survive this termination.






