NOTICE OF TERMINATION

SURFACE TRANSPORTATION BOARD

This Notice of Termination (the "Notice") dated June 11, 2004, memorializes the termination of that certain **LOCOMOTIVE EQUIPMENT LEASE** dated October 6, 1998, by and between **DJJ TRANSPORTATION SERVICES, INC. (N/K/A THE DAVID J. JOSEPH COMPANY)**, a Delaware corporation (hereinafter referred to as "Lessor") and **CENTRAL OF TENNESSEE RAILWAY & NAVIGATION COMPANY, INC.**, a Tennessee corporation (hereinafter referred to as "Lessee"), as amended, (the "Lease"), bearing Recordation Nos. 21735 and 21735-A with respect to 2 locomotives as reflected in Exhibit A attached hereto (hereinafter, the "Equipment").

WHEREAS, Lessor and Lessee executed the Lease relating to the Equipment. The Lease was terminated by Lessor on July 27, 2000, for Lessee's default for nonpayment of rent. Thereafter, Lessee filed bankruptcy and is no longer an existing entity;

WHEREAS, all interest of the Lessor and Lessee, their successors and assigns, in the Equipment arising pursuant to the Lease has been terminated; and

WHEREAS, this Release shall be recorded as STB Recordation No. 21735-B;

NOW, THEREFORE, in consideration of the premises contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lessor submits the following:

1. The Equipment is no longer in service with Lessee.
2. All interest of the Lessor and Lessee, their successors and assigns, in the Equipment arising pursuant to the Lease has been terminated.
3. This Release shall receive STB Recordation No. 21735-B;
