MEMORANDUM OF SECURITY AGREEMENT

SURFACE TRANSPORTATION BOARD

This Memorandum of Security Agreement dated as of May 26, 2004, is by and among GREAT LAKES BANK, N.A. ("Lender") whose address is 2034 Ridge Road, Homewood, Illinois 60430, INDUSTRIAL RAILWAY SWITCHING AND SERVICES, INC. ("Borrower"), whose address is 1020 Washington Street, Chicago Heights, IL 60411, MOBILE LOCOMOTIVE SERVICES, INC. ("Grantor"), B.K. FORGEY, III and ROBERT G. BISCAN (collectively "Guarantors").

1. The Lender has made a loan to the Borrower ("Loan") pursuant to an Amended and Restated Loan and Security Agreement dated as of May 26, 2004 ("Loan Agreement").

- LLX 160 EMD-SW-800


3. Guarantors have executed their continuing unconditional guaranty of all of Borrower's obligations and indebtedness to Lender under the Loan Agreement.






