
MEMORANDUM OF RIDER #4 TO MASTER NET LEASE AGREEMENT

THIS MEMORANDUM OF RIDER #4 TO MASTER NET LEASE AGREEMENT is effective as of July 1, 2004, by and between MIDWEST RAILCAR CORPORATION, an Illinois Corporation ("Lessor"), and THE KANSAS CITY SOUTHERN RAILWAY COMPANY, a Missouri Corporation ("Lessee"), with reference to the following:

1. 2. The Lease shall be effective as of the execution date thereof and the term of the Lease with respect to each car shall be as set forth in Rider #4.




