ASSIGNMENT OF MEMORANDUM OF LEASE AGREEMENT

THIS ASSIGNMENT OF MEMORANDUM OF LEASE AGREEMENT is made and entered into as of November 18, 2004, by and between AMRR CORP. ("Assignee") and HUDSON UNITED BANK, acting through its United Capital Division ("Assignor"), with reference to the following:

Recitals

A. Pursuant to that certain Assignment of Memorandum of Lease Agreement dated as of December 23, 2003 and filed with the Surface Transportation Board on December 30, 2003 as Recordation No. 24752-A, as security for its obligations under a Loan Agreement dated as of December 23, 2003 (the "Loan Agreement"), Assignee previously assigned, set over and transferred to Assignor and its successors and assigns, all of Assignee's right, title and interest in and to that certain Lease Agreement dated as of March 7, 1997, and Equipment Schedules A, B, C, D and G thereto incorporating the terms thereof, together with all of the riders, amendments, lease supplements, schedules and other attachments thereto, between Assignee and National Railroad Passenger Corporation (the "Lease").


B. Assignee has satisfied and paid all of its obligation under the Loan Agreement, and Assignor desires to release its security interest in the Lease and the equipment covered thereby, and to reconvey its interests in the Lease.

NOW, THEREFORE, Assignor hereby assigns, sets over and transfers to Assignee and its successors and assigns, all of Assignor's right, title and interest in and to the Lease and all extensions and renewals thereof, which assignment shall be effective as of the date hereof.


